Public Debt & Equity

SOCIALLY AND ENVIRONMENTALLY SCREENED MUTUAL FUNDS & EXCHANGE TRADED FUNDS (ETFs) | Mutual funds and ETFs that invest in public companies that consider environmental, social and governance (ESG) criteria in their decision making.

Private Debt & Equity

Participate in a diverse range of impact investments that seek to generate significant social and/or environmental impact in addition to financial returns.

PRIVATE DEBT & EQUITY DIRECT IMPACT FUNDS | A rotating selection of professionally managed private debt & equity funds available at lower minimum investment levels.

example: A private equity fund that generates returns by investing in emerging market entrepreneurs delivering essential services to underserved communities.

CUSTOM INVESTMENTS | Client-sourced direct investments in private mission-driven businesses, impact funds and nonprofit organizations.

"TURN-KEY" IMPACT PORTFOLIOS | Four public and private debt and equity asset allocations that provide diversified access to world-class managers. Portfolios span investment time horizons, feature "thematic impact tilts" and are rebalanced quarterly.

Community Investment Options

IMPACTASSETS COMMUNITY INVESTMENT POOL | A professionally managed portfolio that invests in fund managers addressing issues related to community development including affordable housing, financial inclusion, small business funding, sustainable agriculture and fair trade.
